## Water Quality Monitoring

Jack Holland has been keeping on top of the water quality monitoring initiative and is very happy with the YSI Pro 20 digital dissolved oxygen meter the association purchased last year. Maine's Voluntary Lake Monitoring Program (VLMP) is the longest standing citizen lake monitoring program in the U.S., as well as one of the largest, with more than 1,000 active volunteers monitoring more than 500 lakes statewide.
